## Tuolumne County Association of Realtors® California Association of Realtors® Director Appointment Guidelines

The Tuolumne County Association of Realtors® Board of Directors approves the number of CAR voting directors it will appoint and support for the upcoming year. The maximum number of directors is determined by the California Association of Realtors® based on the number of active member of T.C.A.R.

The T.C.A.R. Board of Directors typically appoints the president Elect and President to serve as C.A.R. Directors during their tenure. Additional C.A.R. Directors may be appointed by the T.C.A.R. Board of Directors based on number of eats allotted by C.A.R., budget constraints, and the availability of qualified candidates.

## The T.C.A.R. Board of Directors may qualify candidates for the office of C.A.R. directors based on the following criteria:

- Candidate must have served as a T.C.A.R. Director for at least 2 terms (4 years) and or committee member of one or more of the following committees, Multiply Listing Service or Local Government Relations Committee. Appointee must be a T.C.A.R., C.A.R., & N.A.R. member in good standing, and display an interest in C.A.R. affairs and activities. Candidate's contributions to the Realtor® Action Fund may be considered as appointment criteria. Candidate must be willing to travel to and attend the C.A.R. conferences and meetings. The T.C.A.R. Board of Directors may, at its sole discretion, remove an appointed C.A.R. Director at any time.
- Requirements of C.A.R. Directors appointed by T.C.A.R.:
- All Directors are required to execute a confidentiality agreement upon appointment. Directors should be willing to serve at least 2 years as C.A.R. Director. Directors will be expected to use good judgment, adhere to high ethical standards, and to avoid situations that create an actual or potential conflict between the director's personal interests and the interests of T.C.A.R. Directors will report to the membership in writing after each C.A.R. conference, and at the General Membership meetings of T.C.A.R. upon request of the Board President. Directors will serve on a minimum of 3 C.A.R. committees as directed by the Association Executive /subject to the C.A.R. guidelines.
