Dear Homeowner:

I'm writing to you because you have a housing loan with the County of Tuolumne First Time Homebuyer or Housing Rehabilitation Program and could be eligible for a low or no cost solar photovoltaic system for your home. The County of Tuolumne is partnering with GRID Alternatives, a nonprofit organization that provides solar photovoltaic systems for qualified lower-income homeowners. We are jointly raising funds to install such systems on some of the homes assisted through the County's housing programs. We want to help homeowners save money on monthly utility bills and improve the environment.

Attached is a flyer from GRID Alternatives which provides more information about their work.

In order to participate in the program, your household income would need to be at or below the income level shown on the hand-out. Your home would also need to be "solar panel friendly". For example, your roof is in good condition, has adequate room for solar panels, is structurally strong enough to support the weight of solar panels, has adequate sunshine (trees away from the home), etc. Your electrical panel also needs to be able to accommodate the wiring necessary for solar panels. If you have a homeowner's association, they would have to allow solar panels.

We are compiling an interest list of households that would like to be considered for solar panels and think that your household and home might meet the qualifications above. You don't need to verify that you qualify at this point. We just want to know whether or not you might be interested.

We will contact those on the interest list as funding becomes available.


Who We Serve
